**WHEREAS**, the Purchase Request of the Regional Office-XI for the Provision of Personal Protective Equipment (PPEs) for the management maintenance of the Isolation Facilities in Maragusan, Davao de Oro was approved on May 26, 2021 with an Approved Budget for the Contract (ABC) of **Five Hundred Thousand Pesos (Php 500,000.00)** which is included in the approved **BAYANIHAN 2 FUNDS 2021**;

**WHEREAS**, the Office of Civil Defense (OCD) Region-XI posted the Request for Quotation (RFQ) at the respective Office of Civil Defense (OCD) Website on May 26, 2021;

**WHEREAS**, three (3) prospective bidders, namely; MMJS Pharmacy and Medical Supplies, Karvin Pharma and YourMed Marketing submitted their respective quotations and documents thereof prior to the opening of bids on May 28, 2021;


