WHEREAS, the Purchase Request of the Regional Office-XI for the Provision of Emergency Items for the Emergency Go Bag ICOW the 4th Quarter National Simultaneous Earthquake Drill (NSED) was approved on October 30, 2020 with an Approved Budget for the Contract (ABC) of **Forty Two Thousand Two Hundred Five Pesos (Php 42,205.00)** which is included in the approved **OCDRO-XI DRRM FUND 2020**;

WHEREAS, the Office of Civil Defense (OCD) Region-XI posted the Request for Quotation (RFQ) at the respective Philgeps Website on October 30, 2020;

WHEREAS, three (3) prospective bidders, namely; Davao Outdoor Tours & Adventures, Suntrek Enterprises, & Rocksite Outdoor Gear and submitted their respective quotations and documents thereof prior to the opening of bids on November 4, 2020;


