“RECOMMENDING THE AWARD OF CONTRACT TO SAN JUAN RESORT DEVELOPMENT AND MANAGEMENT CORP. FOR THE LEASE OF VENUE INCLUDING MEALS AND ACCOMMODATION FOR THE ESTABLISHMENT OF ISOLATION/QUARANTINE FACILITY FOR OCD RO1 PERSONNEL AND INCIDENT MANAGEMENT TEAM (IMT) RE: CORONAVIRUS DISEASE 2019 (COVID-19) RESPONSE OPERATIONS”

WHEREAS, on 13 September, 2021, two (2) members of the Regional Incident Management who are stationed at the Incident Command Post located at OCD RO1 Building tested positive of the Corona Virus Disease-2019 with the use of rapid antigen test kits;

WHEREAS, all personnel who were identified close contacts underwent RT-PCR on 14 September;

WHEREAS, the approved Purchase Request (PR) No. 2021-09-0115 of the Operations Section under the Disaster Risk Reduction and Management Division of OCD RO-I for the Lease of venue including meals and accommodation for the establishment of Isolation/Quarantine Facility for OCD RO1 Personnel and Incident Management Team (IMT) re: Coronavirus Disease 2019 (COVID-19) Response Operations was submitted on 14 September 2021;

WHEREAS, the Approved Supplemental Project Procurement Management (PPMP) was submitted by the end-user to the Procurement Management Unit on the same day;

WHEREAS, the Approved Budget for the Contract (ABC) was **Six Hundred Twelve Thousand Five Hundred Pesos (Php 612,500.00)** charged against the DRRM Fund of the Regional Office;

WHEREAS, the Emergency Purchase Certificate EPC No.: 2021-09-0020 was approved by the Head of Procuring Entity recommending the **Alternative Method of Procurement through Negotiated Procurement** in accordance with **Section 53.2 – Emergency Cases** of the Revised Implementing Rules and Regulations of Republic Act No. 9184 for the said project;

WHEREAS, the OCD RO-I through the BAC Secretariat issued the Request for Quotation (RFQ) No. 2021-09-0097 dated September 14, 2021;


WHEREAS, the implementing unit of OCD RO1 made a negotiation with the prospective supplier;


WHEREAS, on the same day, the prospective supplier namely SAN JUAN RESORT DEVELOPMENT AND MANAGEMENT CORP. submitted its quotation;

WHEREAS, the Post Qualification on 04 March 2021 is thereby adopted to declare SAN JUAN RESORT DEVELOPMENT AND MANAGEMENT CORP. as legally, technically, and financially capable supplier for the procurement of the said project;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the Members of the OCD RO-I BAC, by virtue of the functions and responsibilities vested on US by law, hereby recommend to the HOPE the Award of Contract to SAN JUAN RESORT DEVELOPMENT AND MANAGEMENT CORP. with its financial bid amounting to **Six Hundred Twelve Thousand Five Hundred Pesos (Php 612,500.00)** for the "Lease of venue including meals and accommodation for the establishment of Isolation/Quarantine Facility for OCD RO1 Personnel and Incident Management Team (IMT) re: Coronavirus Disease 2019 (COVID-19) Response Operations".
