### “RECOMMENDING THE AWARD OF CONTRACT TO ONEPINE MED DRUG AND GENERAL MERCHANDISE FOR THE PURCHASE OF VITAMIN C FOR OCD REGIONAL OFFICE 3 EMPLOYEES”

**WHEREAS**, the Bids and Awards Committee (BAC) received an approved Purchase Request from the Administrative and Financial Management Section;

**WHEREAS**, the Head of Procuring Entity (HoPE), through the recommendation of the BAC, approved that the Mode of Procurement to be undertaken for the purchase of Vitamin C for the OCD Regional Office 3 Employees be 53.9 (Small Value Procurement) pending the approval of the National Annual Procurement Plan (APP) of the whole OCD;

**WHEREAS**, the BAC, thru its secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to three (3) prospective suppliers, namely: (1) OnePine Med Drug and General Merchandise; (2) MEDC Medical and Drugstore Supply; and (3) Southstar Drug Inc.;

**WHEREAS**, the three prospective suppliers participated and submitted their quotation, to wit:


**NOW, THEREFORE**, We, the members of the BAC hereby recommend to the Head of Procuring Entity, for her consideration and approval, the award of the contract


