“RECOMMENDING THE AWARD OF CONTRACT TO LHANZ CJ TRADING AND COMPUTER CENTER INC FOR THE SUUPLY AND DELIVERY OF ICT PERIPHERALS”

WHEREAS, the Bids and Awards Committee (BAC) received an approved Purchase Request from the Operations Section for the Supply and Delivery of ICT Peripherals;

WHEREAS, the Head of Procuring Entity (HoPE), through the recommendation of the BAC, approved that the Mode of Procurement to be undertaken for the purchase of Vitamin C for the OCD Regional Office 3 Employees will be 53.9 (Small Value Procurement) pending the approval of the National Annual Procurement Plan (APP) of the whole OCD;

WHEREAS, the BAC, thru its Secretariat, initiated the procurement activity by sending the Request for Quotation (RFQ) to four (4) prospective suppliers, namely: (1) Lhancz CJ Trading and Computer Center Inc; (2) Tri-Ace Enterprises; Xaviery Computer Center; and (3) Gilmore Computer Center;


