“DECLARING AE SAMONTE MERCHANDISE AS SINGLE CALCULATED AND RESPONSIVE BIDDER AND FURTHER RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF DISINFECTION AND CLEANING MATERIALS FOR THE MANILA TIMES COLLEGE OF SUBIC, INC. (MTCSI) TEMPORARY TREATMENT AND MONITORING FACILITY (TTMF)”

WHEREAS, Office of Civil Defense Regional Office III Bids and Awards Committee (OCD3-BAC) received a Purchase Request from the Operations Section (OS) for the procurement project, **“PROCUREMENT OF DISINFECTION AND CLEANING MATERIALS FOR THE MANILA TIMES COLLEGE OF SUBIC, INC. (MTCSI) TEMPORARY TREATMENT AND MONITORING FACILITY (TTMF)”** at Subic Bay Freeport Zone with an approved budget for the contract (ABC) amounting to **Php 224,570.00**;

WHEREAS, the BAC, thru its Secretariat, sent Request for Quotation to various suppliers in line with the principle of transparency and competitiveness;

WHEREAS, on 25 June 2021, the BAC convened and deliberated three (3) quotations submitted and one (1) acknowledgement received;

WHEREAS, the BAC recommended to the Head of the Procuring Entity (HoPE) through a resolution, to declare AE Samonte Merchandise with the quotation amounting to One Hundred Ninety-Nine Thousand Four Hundred Eighty Pesos (Php 199,480.00) only as the Single Calculated Bidder and subject the said supplier to Post Qualification (PQ);

WHEREAS, on 29 June 2021, the PQ Team visited AE Samonte Merchandise located in 1128 Escoda Street, Paco, Manila to examine, verify, and validate the original copy of legal and financial documents submitted and conduct inspection at the supplier's office premises;

WHEREAS, the PQ Team submitted the PQ Report during a meeting held on 30 June 2021, and presented the Team's over-all assessment and evaluation;

WHEREAS, the BAC adopts the recommendation of the PQ Team to declare AE Samonte Merchandise as the Single Calculated and Responsive Bidder, having passed the Post Qualification.

NOW, THEREFORE, We, the members of the Bids and Awards Committee (BAC) hereby recommend to the Head of Procuring Entity, for his consideration and approval, to declare **AE Samonte Merchandise** as the Single Calculated and Responsive Bidder and award the contract for the Procurement of Disinfection and Cleaning Materials for the Manila Times College of Subic, Inc. (MTCSI) Temporary Treatment and Monitoring


Facility (TTMF) in the amount of One Hundred Ninety-Nine Thousand Four Hundred Eighty Pesos (Php 199,480.00) only.


