### “RECOMMENDING “A SEVENTY FOUR BISTRO” AS THE LOWEST CALCULATED RESPONSIVE BIDDER (LCRB) FOR THE PROVISION OF MEALS/ CATERING SERVICES FOR THE VIRTUAL UNIFIED FLAG RAISING CEREMONY AND CENTRAL LUZON ASSOCIATION OF REGIONAL OFFICES”

**WHEREAS**, the Bids and Awards Committee (BAC) received an approved Purchase Request from the Public Affairs Office for the Provision of Meals/ Catering Services for the Virtual Unified Flag Raising Ceremony and Central Luzon Association of Regional Offices with an approved budget of contract amounting to Php 33,750.00;

**WHEREAS**, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex “H” of the IRR;

**WHEREAS**, the Canvasser of the Procurement Unit, sent Request for Quotation to various suppliers started on 12 July 2021 and received seven (7) quotations from various suppliers;

**WHEREAS**, on 15 July 2021, the BAC convened and deliberated the quotations submitted, to wit;


