“RECOMMENDING THE AWARD OF PURCHASE ORDER TO ONEPINE MED DRUG AND GENERAL MERCHANDISE FOR THE PURCHASE OF MULTIVITAMINS FOR OCD REGIONAL OFFICE 3 EMPLOYEES WITH ABC Php21,750.00”

WHEREAS, the Bids and Awards Committee (BAC) received an approved Purchase Request from the Administrative and Financial Management Section;

WHEREAS, the approved Mode of Procurement to be undertaken for the Procurement of Multivitamins for the OCD Regional Office 3 Employees be 53.9 (Small Value Procurement) which is included in the **OCDROIII Approved Annual Plans and Budget & Annual Procurement Plan CY 2021**;

WHEREAS, Section 53.9 of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 recognizes Small Value Procurement as a method of procuring goods where the amount involved does not exceed the threshold prescribed in Annex “H” of the IRR;

WHEREAS, the Canvasser of the Procurement Unit, initiated the procurement activity by sending the Request for Quotation (RFQ) to three (3) prospective suppliers, namely: (1) OnePine Med Drug and General Merchandise; (2) Southstar Drug Inc; and (3) Wise Care Pharmacy.;

WHEREAS, the three prospective suppliers participated and submitted their quotation, to wit:
