DISINFECTANT SOLUTION AND ALCOHOL IN SUPPORT TO 24/7
OPERATIONS CENTER DURING COVID-19 ALERT ACTIVATION OF OCDR1
(NOT AVAILABLE IN PS-DBM)**

WHEREAS, the Purchase Request (PR) No. 2021-10-0128 of the Operations Section under the Disaster Risk Reduction and Management Division of OCD RO-I for the Provision of Disinfectant Solution and Alcohol in support to 24/7 Operations Center during COVID-19 Alert Activation of OCDR1 (not available in PS-DBM) was approved and submitted on 18 October 2021;

WHEREAS, on the same day, a Supplemental Project Procurement Management Plan (PPMP) and Emergency Purchase Certificate were submitted by the implementing unit, and approved by OCD RO-I Regional Director Eugene G. Cabrera;

WHEREAS, the BAC Resolution adopting Alternative Method of Procurement Through Negotiated Procurement in Accordance with 52. 1 (b)– Shopping for the project was approved on 20 October 2021;

WHEREAS, the BAC Secretariat issued Request for Quotation on the 22 October 2021;

WHEREAS, on the same day, the RFQ No: 2021-10-0109 was posted through PhilGEPS and conspicuous place;

WHEREAS, seven (7) bidders namely: FREDOWIL MEDICAL SUPPLIES, JEM AND FERDS GENERAL MERCHANDISE, OHANA’S MEDICAL SUPPLIES TRADING, THE ALPHA ENTERPRISE, BLESSING OFFICE SUPPLIES AND EQUIPMENT TRADING, RELIQUA TRADING, AND BAN BEE COMMERCIAL CO., INC. submitted quotation;

WHEREAS, during the opening of bids on 28 October 2021, the OCD RO-I BAC upon the recommendation of the TWG determined that seven bidders passed the technical specifications, financial requirement, and submitted the eligibility documents needed for the project:

WHEREAS, BLESSING OFFICE SUPPLIES AND EQUIPMENT TRADING was declared as the Lowest Calculated Bidder (LCB);

WHEREAS, a Post Qualification was conducted on 11 November 2021 wherein the said LCB was found to be eligible for the Provision of Disinfectant Solution and Alcohol in support to 24/7 Operations Center during COVID-19 Alert Activation of OCDR1 (not available in PS-DBM);

NOW, THEREFORE, for and in consideration of the foregoing, WE, the Members of the OCD RO-I BAC, by virtue of the functions and responsibilities vested on US by law, hereby recommend to the HOPE the Award of Contract to BLESSING OFFICE SUPPLIES AND EQUIPMENT TRADING with its financial bid amounting to **Eighty Four Thousand Three Hundred Twelve Pesos and Fifty Centavos (₱84,312.50)** only for the Provision of Disinfectant Solution and Alcohol in support to 24/7 Operations Center during COVID-19 Alert Activation of OCDR1 (not available in PS-DBM).
