“RECOMMENDING THE AWARD OF CONTRACT TO THUNDER GENERAL MERCHANDIZE FOR THE SUPPLY AND DELIVERY OF PERSONAL PROTECTIVE EQUIPMENT FOR THE PROVINCE OF ILOCOS NORTE RE: COVID-19 PANDEMIC RESPONSE OPERATIONS (NOT AVAILABLE IN PS-DBM)”

WHEREAS, the Purchase Request (PR) No. 2021-11-0140 of the Operations Section under the Disaster Risk Reduction and Management Division of OCD RO-I for the Supply and Delivery of Personal Protective Equipment for the Province of Ilocos Norte re: COVID-19 Pandemic Response Operations (not available in PS-DBM) was approved and submitted on 10 November 2021;

WHEREAS, on the same day, a Supplemental Project Procurement Management Plan (PPMP) and Emergency Purchase Certificate were submitted by the implementing unit, and approved by OCD RO-I Regional Director Eugene G. Cabrera;

WHEREAS, the BAC Resolution adopting Alternative Method of Procurement Through Negotiated Procurement in Accordance with Section 53.2-Emergency Cases for the project was approved on 11 November 2021;

WHEREAS, the BAC Secretariat issued Request for Quotation on the same day;

WHEREAS, the implementing unit sent the Request for Quotation to prospected eligible suppliers;

WHEREAS, three (3) bidders namely: THUNDER GENERAL MERCHANDIZE, MARIWEALTH TRADING, AND LU ZYPER ENTERPRISES submitted quotation;

WHEREAS, upon receipt of the RFQ's, the implementing unit evaluated the bids and determined that three bidders passed the technical specifications, financial requirement, and submitted the eligibility documents needed for the project:

WHEREAS, THUNDER GENERAL MERCHANDIZE was determined as the Lowest Calculated Bidder (LCB);


