WHEREAS, the Purchase Request (PR) No. 2021-12-0159 of the Operations Section under the Disaster Risk Reduction and Management Division of OCD RO-I for the Supply and Delivery of Disinfectant Solution and Alcohol for the COVID-19 Isolation Facilities in Region 1 (Batch 2) (not available in PS-DBM) was approved and submitted on 20 December 2021;

WHEREAS, the Approved Budget for the Contract (ABC) is **One Million Fifty-Eight Thousand Pesos (Php1,058,000.00) only**;

WHEREAS, on the same day, a Supplemental Project Procurement Management Plan (PPMP) and Emergency Purchase Certificate were submitted by the implementing unit, and approved by OCD RO-I Regional Director Eugene G. Cabrera;

WHEREAS, the BAC Resolution adopting Alternative Method of Procurement Through Negotiated Procurement in Accordance with Section 53.2-Emergency Cases for the project was approved on 21 December 2021;

WHEREAS, the BAC Secretariat issued Request for Quotation on 22 December 2021;

WHEREAS, the implementing unit sent the Request for Quotation to prospected eligible suppliers;

WHEREAS, on the same day, three suppliers responded and submitted quotations;

WHEREAS, upon receipt of the quotation, the implementing unit evaluated the bid and determined that the supplier passed the technical specifications, financial requirement, and submitted the eligibility documents needed for the project:

NOW, THEREFORE, for and in consideration of the foregoing, WE, the Members of the OCD RO-I BAC, by virtue of the functions and responsibilities vested on US by law, hereby recommend to the HOPE the Award of Contract to PERFECTSOLUTION CONSUMER GOODS TRADING with its financial bid amounting to **One Million Fifty Thousand and Two Hundred Eighty Pesos (Php 1,050,280.00)** only for the **Supply and Delivery of Disinfectant Solution and Alcohol for the COVID-19 Isolation Facilities in Region 1 (Batch 2) (not available in PS-DBM).**
