**“RECOMMENDING THE AWARD OF CONTRACT TO PALMER-ASIA INC. FOR

OF ILOCOS NORTE RE: COVID-19 PANDEMIC RESPONSE OPERATIONS

**WHEREAS**, on August 25, 2021, this regional office received the letter request of the province of Ilocos Norte which pertains to the provision of logistical support in line with its crisis mitigation strategy specifically in addressing the urgent needs for isolation units;

**WHEREAS**, on August 26, 2021, OCD RO-1 requested for the modification of unutilized downloaded funds to OCD Central Office which shall cover the procurement of modular tents for the Province of Ilocos Norte;

**WHEREAS**, on 10 September 2021, Presidential Proclamation No. 1218 “Extending the Period of a State of Calamity Throughout the Philippines due to Corona Virus Disease 2019 declared Under Proclamation No. 1021, s. 2020” has been issued directing all government agencies to continue rendering full assistance to and cooperation with each other to mobilize resources to undertake critical, urgent, and appropriate disaster response aid and measures in a timely manner to stop the spread and eliminate the threat of COVID-19;

**WHEREAS**, on 13 September 2021, OCD Central Office granted authority to OCD RO-I to utilize its available balance;

**WHEREAS**, on 16 September 2021, the Operations Section under the Disaster Risk Reduction and Management Division of OCD RO-I requested the project Provision of Portable Isolation Facilities for the Province of Ilocos Norte re: COVID-19 Pandemic Response Operations (Batch 2);

**WHEREAS**, on the same day, an approved Supplemental Project Procurement Management Plan (PPMP) was received by the Procurement Management Unit;

**WHEREAS**, on 17 September 2021, the Emergency Purchase Certificate was approved by the Head of Procurement Entity (HoPE);

**WHEREAS**, the Approved Budget for the Contract (ABC) was **Five Million Pesos (5, 000,000.00)** charged against the Quick Response Fund downloaded to the Regional Office;

**WHEREAS**, upon receipt of the bid proposal, the Bids and Awards Committee (BAC) and the Technical Working Group reviewed the validity of the submitted documents;


**WHEREAS**, on 29 September 2021, the implementing unit with the assistance of the Procurement Management Unit, conducted post-verification with the supplier and submitted report to the BAC;


**NOW, THEREFORE**, for and in consideration of the foregoing, **WE**, the Members of the OCD RO-I BAC, by virtue of the functions and responsibilities vested on US by law, hereby recommend to the HOPE the Award of Contract to PALMER-ASIA, INC. with its financial bid amounting to **Four Million Nine Hundred Sixty Thousand Pesos (Php 4,960,000.00)** for the **PROVISION OF PORTABLE ISOLATION FACILITIES FOR THE PROVINCE OF ILOCOS NORTE RE: COVID-19 PANDEMIC RESPONSE OPERATIONS (BATCH 2)**.


