“A RESOLUTION RECOMMENDING THE AWARD TO THE LEGALLY, TECHNICALLY, AND FINANCIALLY CAPABLE AND RESPONSIVE BIDDER FOR: PROVISION OF MEALS (BREAKFAST, LUNCH AND DINNER) FOR DUTY PERSONNEL AT OCD-RDRRMC7 OPERATION CENTER (MARCH 01-31, 2021) UNDER NEGOTIATED PROCUREMENT -EMEGENCY CASES OF R.A. 9184 ANDTHE ISSUANCE OF NOTICE OF AWARD (NOA).”

WHEREAS, on 16 September 2020, the Proclamation No. 1020 extending the period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 (COVID-19) declared under Proclamation No. 929, s. 2020.

WHEREAS, Republic Act No. 11519 entitled “An Act extending the availability of appropriations under Republic Act No. 11494, otherwise known as the Bayanihan to Recover As One Act” was approved to allow the government to continue its programs and efforts;

WHEREAS, the Alternative Mode of Procurement through Negotiated Procurement – Emergency Cases under 53.2 of the Revised Implementing Rules and Regulations of RA 9184, to wit: Section 53(b) of RA 9184 and Section 53.2 of its 2016 Revised IRR provide that Negotiated Procurement may be resorted to by procuring entities in case of imminent danger to life or property during a state of calamity, or when time is of the essence arising from natural or man-made calamities or other causes where immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastructure facilities and other public utilities;

WHEAREAS, the Bids and Awards Committee (BAC) is authorized to resort to Alternative Method of Procurement in Accordance with the provisions of Section 53.2 of the 2016 revised IRR of RA 9184 (Emergency Cases) as per approved authority.

WHEREAS, the guideline of the procurement thru emergency cases under the GPPB Non-Policy Matter Opinion No. 003-2020 dated 23 March 2020 as stated the “the HOPE may also authorize the End-user unit or any other appropriate procuring units to directly negotiate with a legally, technically, and financially capable supplier, contractor, or consultant. Hence, the BAC need not be the one to negotiate or procure” and “Per GPPB Resolution No. 03-2020, emergency cases procurement can also be resorted to for the provision of immediate response and initial recovery steps to avoid loss of life, injury, disease and other negative effects on human, physical mental and social well-being, together with damage to property, destruction of assets, loss of services, social and economic disruption and environmental degradation”.

WHEREAS, the request for quotation for the project “Provision of Meals (Breakfast, Lunch and Dinner) for duty personnel at OCD-RDRRMC7 Operation

Center (March 01-31, 2021), in the amount of Seventy-Seven Thousand Five Pesos (77,500.00) only;

WHEREAS, the project provides transportation services to personnel of OCD Region 7 of the aforesaid activity;

WHEREAS, the BAC found the offer of MIGGAB Eatery as responsive and accordance with the preference of the End-User.


