**“A RESOLUTION RECOMMENDING THE AWARD TO LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROVISION OF MEALS, SNACKS, VENUE AND ACCOMMODATIONS FOR THE CONDUCT OF 3-DAY COMMUNITY-BASED DRRM TRAINING FOR THE LDRRMOS OF CEBU PROVINCE ON MARCH 29, 30 & 31, 2021 IN CEBU AND THE ISSUANCE OF NOTICE OF AWARD (NOA).”**

WHEREAS, Section 7.6 of the 2016 revised IRR of RA No. 9184 states that “to facilitate the immediate implementation of procurement of Goods, Infrastructure Projects or Consulting Services, even pending approval of the General Appropriations Act (GAA), corporate budget or appropriations ordinance, as the case may be, and notwithstanding Section 7.2 hereof, the procuring entity (PE) may undertake the procurement activities short of award. xxx No award of contract shall be made until the GAA, corporate budget or appropriations ordinance, as the case may be, has been approved or enacted”;

WHEREAS, Resolution no.14-2019 dated 17 July 2019, Approving the issuance of the circular on the implementation of early procurement activities and amending sections 7.5, 7.6 and 20.1(c)(i) of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, the affected clauses in the generic procurement manuals, and the annual procurement plan and procurement monitoring report formats

WHEREAS, OCD Memorandum No. 462, s. 2020 dated 30 September 2020, conduct of Early Procurement Activity in relation to the approved FY 2021 Indicative APP consistent with the FY 2021 NEP beginning 01 October 2020.

WHEREAS, the request for quotation for the project “Provision of Meals, Snacks, Venue and Accommodations for the conduct of 3-day Community-Based DRRM Training for the LDRRMOS of Cebu Province on March 29, 30 & 31, 2021 in Cebu, in the amount of Two Hundred Eleven Thousand Two Hundred Pesos (211,200.00) Only;

WHEREAS, the project provides venue, meals, AM & PM Snacks and accommodation to participants of the aforesaid activity;

WHEREAS, opening of quotation was held on December 18, 2020 wherein three proponents submitted their respective quotations, as follows;

WHEREAS, **BAI HOTEL CEBU** has been evaluated to have offered the lowest calculated bid for the project in the amount of One Hundred Ninety-Five Thousand Pesos (195,000.00) only.
