**“RECOMMENDING THE AWARD OF CONTRACT TO THE DAVAO TOURIST TRANSPORT SERVICE COOPERATIVE THROUGH ALTERNATIVE PROCUREMENT UNDER SECTION 53.9 (SMALL VALUE PROCUREMENT) FOR THE VAN RENTAL FOR OCD XI PERSONNEL FROM OCTOBER 2021 TO JANUARY 2022”**

**WHEREAS**, the Purchase Request of the Regional Office-XI for the Van Rental for OCD XI Personnel from October 2021 to January 2022 was approved on September 29, 2021 with an Approved Budget for the Contract (ABC) of **Two Hundred Eighty Three Thousand Five Hundred Pesos (Php 283,500.00)** which is included in the approved **OCDRO-XI CDE FUND 2021**;

**WHEREAS**, the Office of Civil Defense (OCD) Region-XI posted the Request for Quotation (RFQ) at the respective Office of Civil Defense (OCD) website and PhilGEPS website on October 8, 2021;

**WHEREAS**, four (4) prospective bidders, namely; Davao Tourist Transport Service Cooperative, A-Five Car Rental, DCND Transport Service and Punisher Van Rental submitted their respective quotations and documents thereof prior to the opening of bids on October 14, 2021;

**WHEREAS**, opening of quotation was held on October 14, 2021 wherein four (4) proponents submitted their respective quotations as follows:

**WHEREAS**, Davao Tourist Transport Service Cooperative, has been evaluated as the **Single Calculated Bid** for the project in the amount of Two Hundred Thirty Four Thousand Pesos (**Php 234,000.00**) only;

**WHEREAS**, the post qualification dated October 5, 2021 of the said bidder was used as basis;

**WHEREAS**, Section 12 of RA 9184 mandates that the Office of Civil Defense Bids and Awards Committee (OCD-BAC) shall recommend the award of the contract to the Head of the Procuring Entity or his/her duly authorized representative;

**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the members of the OCD-BAC, hereby RECOMMEND to the Head of the Procuring Entity (HoPE), the following;

- a. To declare **DAVAO TOURIST TRANSPORT SERVICE COOPERATIVE** as the **Single Calculated Responsive Bidder** for the Van Rental for OCD XI Personnel from October 2021 to January 2022;
- b. The issuance of a Notice of Award (NOA) in favor of **DAVAO TOURIST TRANSPORT SERVICE COOPERATIVE** in the amount of Two Hundred Thirty Four Thousand Pesos (**Php 234,000.00**) only;




