**“RECOMMENDING THE AWARD OF CONTRACT TO MALAGOS GARDEN RESORT INC. THROUGH ALTERNATIVE MODE OF PROCUREMENT UNDER SECTION 53.10 (LEASE OF VENUE) FOR THE PROVISION OF MEALS AND MEETING VENUE AND ACCOMMODATION FOR THE PARTICIPANTS FOR THE PRE-FINALIZATION OF THE UPDATED RDRRMP ON OCTOBER 29, 2021”**

**WHEREAS**, the Purchase Request of the Regional Office-XI for the Provision of meals and meeting venue and accommodation for the participants for the Pre-finalization of the updated RDRRMP on October 29, 2021 was approved on October 19, 2021 with an Approved Budget for the Contract (ABC) of **Twenty Six Thousand Nine Hundred Fifty Pesos (Php 26,950.00)** which is included in the approved **OCDRO-XI DRRM FUND 2021**;

**WHEREAS**, the Office of Civil Defense (OCD) Region-XI posted the Request for Quotation (RFQ) at the respective Office of Civil Defense (OCD) Website on October 22, 2021;

**WHEREAS**, three (3) prospective bidders, namely; Malagos Garden Resort Inc., Eden Mountain Resort Inc. and Davao Bamboo Sanctuary and Ecological Park submitted their respective quotations and documents thereof prior to the opening of bids on October 26, 2021;

**WHEREAS**, opening of quotation was held on October 26, 2021 wherein three (3) proponents submitted their respective quotations as follows:






