WHEREAS, the mode of procurement is Section 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 16 December 2020;

FURTHER, We, the members of OCD-BAC hereby **RECOMMEND** to the HOPE the following:


- a. Approval of the recommendation to declare **Kaifashion Philippines Incorporated** as the Lowest Calculated and Responsive Bidder; and
