WHEREAS, the BAC received a Purchase Request from the PAO for the project “Provision of Printing Services” whose funding source is from the PAO APB CY 2020;

WHEREAS, the Approved Budget for the Contract is One Hundred Eighty Five Thousand Six Hundred Forty Pesos (PhP 185,640.00) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the PhilGEPS Website, in the OCD Website, and in the OCD Bulletin Board on 12 December 2020;

WHEREAS, the mode of procurement is Section 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 16 December 2020;



- b. Issuance of a corresponding Notice of Award (NOA).


