**“RECOMMENDING SALAZAR EATERY AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF MEALS FOR OCD EMPLOYEES ON SKELETON WORKFORCE DUE TO COVID-19 PANDEMIC (1 JANUARY TO 31 MARCH 2021) AND THE ISSUANCE OF NOTICE OF AWARD”**

**WHEREAS**, Republic Act 11494 was approved on 11 September 2020 with subject “Bayanihan to Recover As One Act” to provide COVID-19 Response and recovery interventions and to provide mechanisms to accelerate the recovery and bolster the resiliency of the Philippine Economy, Providing Funds therefor, and for other purposes;

**WHEREAS**, Proclamation No. 1021 was issued on 16 September 2020 extending the period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 since the number of COVID 19 positive cases and deaths continue to rise despite the efforts and interventions to contain the same;

**WHEREAS**, the provision of meals was urgently requested by the Human Resource Management and Development Division to continue providing assistance to OCD Personnel scheduled on skeleton workforce during COVID 19 Pandemic;

**WHEREAS**, the BAC received a Purchase Request from the HRMDD for the project “Provision of Meals for OCD Employees on Skeleton Workforce due to COVID-19 Pandemic (1 January to 31 March 2021)” whose funding source is from the Reprogrammed Funds DRRM;

**WHEREAS**, the Approved Budget for the Contract is Six Million Nine Hundred Sixty Six Thousand Pesos (PhP 6,966,000.00) only;

**WHEREAS**, the mode of procurement is Section 53.2 (Emergency Cases) of Republic Act. No. 9184 and its IRR and the deadline for the submission of eligibility and financial requirements of the project was on 23 December 2020;

**WHEREAS**, the quotations / acknowledgements were opened on 23 December 2020 with the following results:
