“RECOMMENDING GREAT EASTERN HOTEL, INCORPORATED AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF HOTEL/VENUE/ACCOMMODATION FOR THE CONDUCT OF 2-DAY INCIDENT COMMAND SYSTEM EXECUTIVE COURSE FOR OCD PERSONNEL (BLENDED) (02-04 JUNE 2021) AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the BAC received a Purchase Request from the CBTS for the project **“Provision of Hotel/Venue/Accommodation for the Conduct of 2-Day Incident Command System Executive Course for OCD Personnel (Blended) (02-04 June 2021)”** whose funding source is from the CBTS APB FY 2021;

WHEREAS, the Approved Budget for the Contract is Seventy Thousand Four Hundred Pesos (PhP 70,400.00) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the OCD Website, and in the OCD Bulletin Board on 24 March 2021;

WHEREAS, the mode of procurement is Section 53.10 (Lease of Real Property and Venue) and the deadline for the submission of eligibility and financial requirements of the project was on 30 March 2021;

WHEREAS, the quotations / acknowledgements were opened on 31 March 2021 with the following results:

WHEREAS, a Post Qualification was conducted on 6 April 2021, to verify, validate, and ascertain their submitted documents by the OCD Central Office PQ Team composed of Ms. Aimee Menguilla, Ms. Janine Casimiro, and Ms. Hyacinth Jeaned Barros, supported by Ms. Bebeth Gador of the BAC Secretariat. The PQ Team submitted a report to the BAC dated 8 April 2021, recommending the proponent as the Lowest Calculated and Responsive Bidder;


NOW, THEREFORE, the BAC, after due deliberation resolved to recommend to declare **Great Eastern Hotel, Incorporated** as the Lowest Calculated and Responsive Bidder;
