and

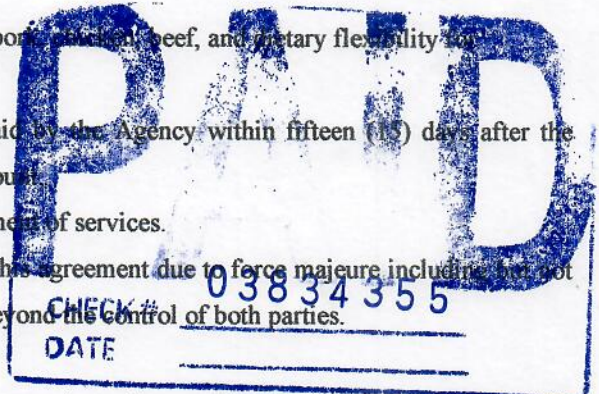

WHEREAS, the **OCDRO VII** invited bids/quotations for certain goods and ancillary services, viz., Meals, AM and PM Snacks for **Provision of Meals and snacks for Repatriation Team during the arrival of Returning Overseas Filipinos at Mactan-Cebu International Airport (MCIA), Lapu-Lapu City, Cebu. (March 15-April 13, 2021)**, for the supply of those good and catering services in the sum of **Three Hundred Thirty Thousand Pesos (330,000.00) only** hereinafter called "**the CONTRACT PRICE**";

**NOW, THIS AGREEMENT WITNESSETH as follows:**

1. **MIGGAB EATERY** shall provide **OFFICE OF CIVIL DEFENSE REGIONAL OFFICE VII** the Meal (Diner) and PM snacks for:
2. **Event Name: Repatriation Team during the arrival of Returning Overseas Filipinos at Mactan-Cebu International Airport (MCIA), Lapu-Lapu City, Cebu**
3. **Event Date & Location: March 15, 2021-April 13, 2021 (30 days) at Mactan-Cebu International Airport, Lapu-Lapu City, Cebu**
4. Meal and snacks must be packed in reusable container with fork and spoon good for **55 persons**.
5. Serving Time: 4:00 PM – 5:00 PM
6. Catering/Supplier must be able to adjust to the abrupt changes in the number of persons/pax needed for the event.
7. Use clean, biodegradable, environment friendly and/ or reusable containers
8. Flexible with dietary requirements
9. Meals must be balanced with a variety of fish, vegetables, pork, chicken, beef, and dietary flexibility for participants with allergy and non-pork eaters.
10. The payment due to the **MIGGAB EATERY** shall be paid by the Agency within fifteen (15) days after the receipt of the submitted billing statement/ statement of account.
11. **MIGGAB EATERY** agreed a Send Bill Policy in the payment of services.
12. Both parties shall not be liable for failure to comply with this agreement due to force majeure including but not limited to labor disputes, natural disaster, or other causes beyond the control of both parties.




NOWHEREFORE, in consideration of the foregoing premises, the parties hereto have agreed to the abovementioned terms and condition;
