This Contract of Service made and entered into by and between:

and

MIGGAB EATERY with business and postal address at 712-A Tres De Abril, Brgy., Labangon, Cebu City and herein represented by its Authorized Representative, **MR. CLEO B. BARING** of legal age, Filipino, hereinafter known as the **SERVICE PROVIDER**;

Lunch: 11:30 AM
Dinner: 3:00PM
7. Catering/Supplier must be able to adjust to the abrupt changes in the number of persons/pax needed for the event.
8. Use clean, biodegradable, environment friendly and/ or reusable containers
9. Flexible with dietary requirements
10. Meals must be balanced with a variety of fish, vegetables, pork, chicken, beef, and dietary flexibility for participants with allergy and non-pork eaters.
11. The payment due to the **MIGGAB EATERY** shall be paid by the Agency within fifteen (15) days after the receipt of the submitted billing statement/ statement of account;
12. **MIGGAB EATERY** agreed a Send Bill Policy in the payment of services.
13. Both parties shall not be liable for failure to comply with this agreement due to force majeure including but not limited to labor disputes, natural disaster, or other causes beyond the control of both parties.


