Supply and delivery of sleeping kits for the nine (9) COVID-19 Isolation Facilities in Region 1 to allow comfortable recovery of the patients admitted.

Project Title: **Supply and Delivery of Sleeping Kits for the COVID-19 Facilities in Region 1**

Conditions and Circumstance:

In view of the Department of Health's confirmation on local transmission of the Coronavirus Disease 2019 (COVID-19) in the Philippines, the National DRRM Operations Center and the Regional DRRM Operations Center elevated the alert status to "RED" effective 21 March 2020. This is to closely monitor the area of responsibility (AOR), consolidate and report all related incidents and ensure timely dissemination of precautionary measures and advisories to the public and prompt coordination among concerned agencies and offices in responding the COVID-19 threat. On 24 March 2020, Republic Act 11469 or the "Bayanihan to Heal as One Act" was signed into law declaring a national state of emergency due to COVID-19. Following this, the Provincial Governments of Ilocos Norte, Ilocos Sur, La Union, and Pangasinan implemented the State of Community Quarantine to prevent local transmission of the said disease.

Ensuing the "Bayanihan to Heal as One Act" or the Bayanihan Act 1, Republic Act 11494 or the "Bayanihan to Recover as One Act" also known as the Bayanihan Act 2 was signed into law on 11 September 2020. Through this new act, funds are made available to support the continuous efforts and to strengthen the coronavirus pandemic response and recovery efforts of the government. To further assist the operations and budgetary requirements of the four provinces, the Regional Disaster Risk Reduction and Management Council (RDRRMC1) through the Office of Civil Defense Regional Office 1 (OCDRO1) shall provide logistic assistance to augment the resources of the local government units in Region 1 particularly the supply and delivery of sleeping kits for the COVID-19 isolation facilities in Region 1.
