**WHEREAS**, the Approved Budget for the Contract is **Twenty Seven Thousand Pesos Only (P 27,000.00)**;

**WHEREAS**, in line with the principle of transparency and competitiveness, the RFQ was posted in the PhilGEPS Website and in the OCD Bulletin Board on 1 April 2021;

**WHEREAS**, the mode of procurement is Section 53.9 (Small Value Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on 7 April 2021;
