“RECOMMENDING CK TRUMART FOODS CORP. AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROVISION OF CATERING SERVICES INTENDED FOR THE 65-ROOM WITH 65 PAX CAPACITY OF THE KONTRA COVID-19 ISOLATION FACILITY FOR THE MUNICIPALITY OF CONCEPCION, ILOILO AND THE ISSUANCE OF NOTICE OF AWARD”

WHEREAS, the BAC received a Purchase Request from Operations Section (Annex A) for the project “Provision of catering services intended for the 65-room with 65 pax capacity of the Kontra Covid-19 Isolation Facility for the Municipality of Concepcion, Iloilo whose funding source is from OCD QRF 2020 (Annex B);

WHEREAS, the Approved Budget for the Contract is Seven Hundred Eighty Thousand Pesos (PhP780,000.00) only;

WHEREAS, in line with the principle of transparency and competitiveness, the RFQ was posted in the Philgeps, OCD website and in the OCD Bulletin Board on December 7, 2020 (Annex C);

WHEREAS, the mode of procurement is 53.9 (Negotiated Procurement) and the deadline for the submission of eligibility and financial requirements of the project was on December 11, 2020, 9:00 a.m.;
